WHY

The CSA Program consists of three (3) key components that work together to improve Safety on North America's highways:

1. The Safety Measurement System or SMS
2. The Safety Interventions Process
3. The Safety Fitness Determination or SFD

The Safety Measurement System (SMS) is at the heart of the CSA. It assesses motor carrier safety compliance and identifies carriers for interventions.

Five (5) Serious Violations that are currently used in FMCSA investigations, that took effect in the SMS as of February 1, 2015:

HM Compliance

- Regulation 172.704(a)(4): Failing to provide security awareness training.
- Regulation 172.704(a)(5): Failing to provide in-depth security awareness training.

Driver Fitness

Regulation 383.37(c): Knowingly allowing, requiring, permitting, or authorizing an employee with more than one commercial driver's license to operate a commercial motor vehicle.

Hours-of-Service (HOS) Compliance

Regulation 395.3(a)(3)(i): Driving Violation.
Regulation 395.3(a)(3)(ii): Rest Periods Violation.

YOU Maybe Penalized for DOT Intervention, if:

- You exceed acceptable thresholds for the 7 Basics, based on a given BASIC's relationship to crash risk.
- You have Serious Violations found during investigations, the type of commodity you haul, your intervention history, or the time since your last intervention.
- Carriers with one or more BASICs identified for interventions had a 79% higher crash rate than those with no BASICs identified for interventions.
