- FMCSA Report 2016 outlines the Safety Interventions Process-Interventions that may be taken when a Carrier's safety performance data indicates a potential safety risk and application of the FMCSA's Safety Management Cycle - SMC- a methodical process that helps Carriers to understand and correct safety problems. The SMC considers six(6) areas or Safety Management Process (SMPs) of a Carrier's operations, of which Training is one of the processes recommended for corrective action.
- According to MTO Commercial Vehicle Operator Policy, Carriers have a legal obligation to undertake occupational health and safety actions to make sure staff is properly trained and retrained to carry out their duties effectively.
- Insurance companies also recommend ongoing training for your drivers.
- Transport regulators require mandatory training, with annual retraining for all drivers hired.
